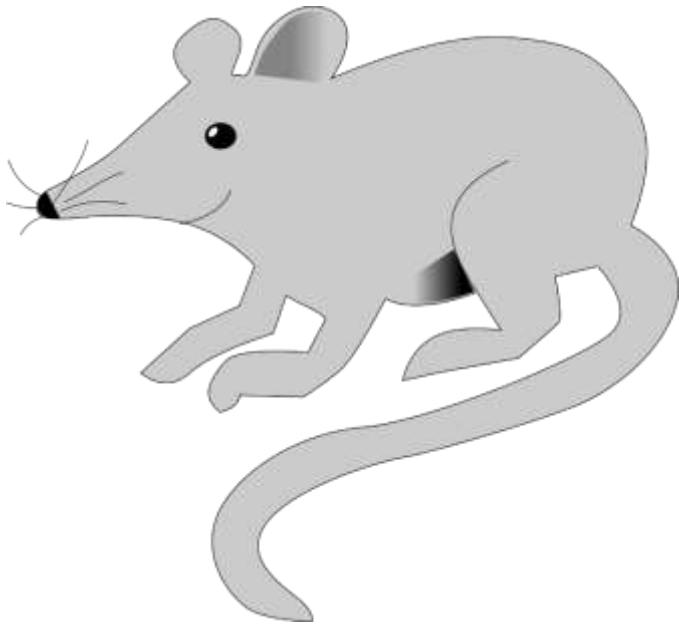

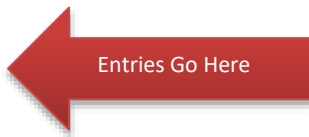

**EXHIBITOR INFORMATION**

All dogs must be on a short leash and under control while on trial grounds except while showing. **FLEXI LEASHES ARE NOT PERMITTED INSIDE ANY BUILDINGS.** There is **NO SMOKING** in this facility or on the grounds. If you must smoke you will need to do so inside your vehicle Please pick up after your dog and dispose of waste in appropriate containers outside the building.

**RUNNING ORDER:**

Trial 1 Ratter/Happy Ratter/Expert/Champion/Extraordinaire

Trial 2/3 (2 runs back to back) Extraordinaire/Champion/Expert/Happy Ratter/Ratter

**AWARDS:** Ribbons will be awarded for all qualifiers, titling ribbons!!

Bring water for your dog and yourself. There are fast food choices nearby. There are porta potties on site.

**Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial.** Entry fees for bitches that come into season will be refunded until the time of the trial if you wish to withdraw. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.
